



## **WAMA Foundation Ltd (WAMA) Conditions of Sale for Artworks**

1. A contract of sale for works purchased from WAMA will not be deemed concluded until:

- I. the purchaser places an order with WAMA;
- II. WAMA has received payment in full and cleared funds from the purchaser for the works, packaging, insurance, and delivery costs; and
- III. WAMA has sent a written confirmation of the sale to the purchaser (**Contract**).

2. A Contract may not be altered or cancelled once concluded by the purchaser unless agreed in writing by WAMA. WAMA agrees to alter or cancel an order, the purchaser must pay any costs incurred by WAMA in connection with the alteration or cancellation.

### **DELIVERY**

3. Cost of packaging, insurance, and delivery within Australia and international destinations will be determined on an individual basis by WAMA ([info@wamafoundation.com.au](mailto:info@wamafoundation.com.au)) and notified to the purchaser. Packaging, insurance, and delivery costs will be payable by the purchaser in addition to the sale price of the artwork.

4. Once a Contract has been concluded in accordance with 1 above and after the exhibition closes on 9 March 2026, WAMA will email the purchaser within 10 business days with the carrier details, tracking number where relevant and estimated arrival time. WAMA will take reasonable steps to ensure that delivery of purchased works will occur within 15 business days after the exhibition closes on 09 March 2026.

5. Delivery times may vary and are an estimate only. As delivery is done by a third party, delivery times are outside the control of WAMA and WAMA shall not be liable for any failure to meet estimated delivery times.

6. Copyright in the works and all visual depictions of the works on the WAMA website is held by the originators the works. Copyright in all other materials and information on the



website is held by WAMA. No visual depiction or material may be used for any purpose without prior written consent of the copyright holders.
